

Rules, Waiver & Photography Release

- 1. Players must be 6 years old on the day of play for splatmaster-paintball & Lasertag, and 11 years of age for Paintball.
- 2. Goggles must remain on at all times while on the playing field. Never remove or lift your while playing. Always follow the staff/referee's instructions.
- 3. Barrel bags MUST be on your paintball marker before entering the safe area. Never remove your barrel bag outside the playing field unless the marker is properly degassed with no remaining pressure inside.
- 4. Paint and Airsoft guns may only be discharged while in the playing field. Never fire the gun outside the designated playing area whether there is paint or BBs in the gun or not.
- 5. Physical contact with other players or staff is not permitted.
- 6. Paintballs must be purchased from Stingers Indoor Paintball. Persons caught with non-field paint will be asked to leave/have their paint destroyed unless it is a special event such as BYOP.
- 7. Always handle paintball, airsoft, and Lasertag guns in a safe and responsible manner.

WAIVER AND RELEASE OF LIABILITY FORM

RELEASE OF LIABILITY, WAVE OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT. BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE TO: Stingers Indoor paintball Inc.

Assumption of Risk

- 1. I, the undersigned, wish to play/compete in Paintball and/or Airsoft and/or Laser tag and/or Field Sports; I recognize and understand that playing Paintball/Airsoft/Lasertag/Field Sports (herein after called "The Game") involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the game and injuries from tripping or falling over obstacles in the game playing field. In addition, I recognize that the exertion of playing the game could result in injury or death.
- 2. Despite these and other risks, and fully understanding such risks, I wish to play The Game and hereby assume the risks of playing the Game. I also hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions, suits, procedure's, costs, expenses (including attorney fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including without limitation, those resulting from the manufacturers, selection, delivery, possession, use or operation of such equipment. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the Game, I further certify that I am 18 years of age or older.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT
